

SUMMARY ANNUAL REPORT

For Retirees of The Goodyear Tire & Rubber Company Health Care Plan

This is a summary of the annual report of the Retirees of The Goodyear Tire & Rubber Company Health Care Plan, EIN 26-6330284, Plan No. 501, for period January 01, 2013 through December 31, 2013. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has a contract with Delta Dental Plan of Ohio to pay dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2013 were \$1,875,668.

Because it is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2013, the premiums paid under such "experience-rated" contract were \$1,875,668 and the total of all benefit claims paid under the contract during the plan year was \$1,699,623.

The plan also has contracts with Highmark Blue Cross and Blue Shield to pay medical benefits and with CVS/Caremark to pay prescription drug benefits, both on a "self-funded" basis. For the plan year ending December 31, 2013 the total payments for medical benefits were \$78,168,079, and the total payments for prescription drug benefits were \$71,545,366.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$916,002,561 as of December 31, 2013, compared to \$997,532,816 as of January 01, 2013. During the plan year the plan experienced a decrease in its net assets of \$81,530,255. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$91,813,726, including employer contributions of \$23,111,202, employee contributions of \$27,870,474, earnings from investments of \$10,981,603, and other income of \$29,850,447.

Plan expenses were \$173,343,981. These expenses included \$9,107,361 in administrative expenses, and \$164,236,620 in benefits paid to participants and beneficiaries.

- transactions in excess of 5% of the plan assets;
- insurance information, including sales commissions paid by insurance carriers;
- information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
